

Rules & Regulations:

GENERAL

1. The Event Director's decision shall be final and conclusive and no correspondence, queries, appeals or protests shall be entertained.
2. *Dental Society, Faculty of Dentistry, University of Malaya* shall not be held responsible for any disputes arising from incomplete entry details.
3. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to use any photographs, motion pictures, recordings, or any other records of the Event for any legitimate purposes, including commercial advertising.
4. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to limit and refuse entries without assigning any reasons thereof.
5. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to amend the Rules and Regulations without giving prior notification or any reasons thereof by displaying at any means of communication that may be deemed appropriate by Dental Society, Faculty of Dentistry, University of Malaya.
6. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to change the event date or venue at their own discretion.
7. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to use any photographs (including those of participants), motion pictures, recordings, or any other media records of the Event, for any legitimate purpose including commercial advertising and distribution to the Sponsors.

8. There is no insurance coverage for participants in this event. It is recommended that participants have their own personal accident insurance or health insurance.

EVENT REGISTRATION

1. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to cancel or postpone of this event, CLAP Run, University of Malaya at any time without prior notice to the participants, in which case they will make an effort to inform the participant prior to the date of the event. If CLAP Run, University of Malaya has been cancelled or postponed, there shall be no refund of registration fees paid and the organizer shall not be liable for any other loss or inconvenience caused.
2. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to set the fees for the different categories as expedient to its intents and purposes.
3. Participant shall provide true, accurate, current and complete information about the participant. The Organiser may contact the participant from time to time by email. Any notice send to the email address registered with the Organiser deem as receive by the participants. If the participants provide any information that is untrue, inaccurate, not current or incomplete, or if the Organiser have ground to suspect that such information is untrue, inaccurate, not current or incomplete, the Organiser may at any time suspend, revoke, cancel or terminate the participant's registration and participation in the event and refuse any and all

current or future use of the event's official website (or any parts thereof)

4. *Dental Society, Faculty of Dentistry, University of Malaya* will not entertain nor be in any way responsible for any disputes arising from incomplete or inaccurate entry details in the registration form.
5. Once participant's registration has been duly processed, there will be no fee refund for participant who does not eventually take part in the event for whatever reason.
6. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to cancel, defer and or add any event category without prior notice to the participant.
7. Participant is strictly not allowed to transfer their event entry to another party or change the event categories after his/her registration is confirmed.
8. Participation is open to all irrespective to nationality.
9. Age qualification is taken as at 8th April 2018.
10. Participants aged below 18 must be accompanied and/or get permission from parents. Parents/ guardian who wish to accompany must register for the run.
11. For *family fun run category*, it is upon adult participants' responsibilities to make sure they are able to take care of their children taking part in the event.
12. Babies that are 2 years old and below are free of charge but will not be getting any entitlements e.g. medals, tshirts, etc. . Parents are allowed to carry babies with strollers during the event.
13. For *virtual run category*, the price includes postage and Address 1 will be the shipping address for the participants.

14. Whilst every reasonable precaution will be taken by the organizer to ensure the participants safety, participants take part at their own risk and the organizer will not be responsible or held liable for any injury or death howsoever arising from training for or during participation in the race.
15. Change in size during collection of the race event tee is strictly NOT ALLOWED. Participants must adhere to the race event tee sizes that they have registered for.
16. Last day for early bird registration is 11th March 2018. Deadline for registration is on 8th April 2018.
17. Participants agree to receive contact from the event from time to time by email/SMS blast. Any notice sent by email from *Dental Society, Faculty of Dentistry, University of Malaya* or party assigned by the Organizers to the supplied address on the registration form shall be assumed received by the Participants.
18. Participant agree to accept promotional materials/items from the Organiser whether in relation to the event or otherwise.

EVENT PARTICIPATION

1. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to amend the CLAP Run, University of Malaya routes as they deem fit for the safety of the participants and/or to prevent any potential hazards in the running of the event, at any time without prior notice to the participant.

2. *Dental Society, Faculty of Dentistry, University of Malaya* shall not be liable for any other loss or inconvenience caused due to such changes.
3. Participants must wear their assigned number bib on his/ her chest at all times during the run. Participants without the allocated bib number will not be allowed to take part in the run.
4. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to delay the commencement of the run in the event of inclement weather. Should the inclement weather persist after the delay, the organizer reserves the right to cancel the race without refund of registration fees.
5. For appeal over disputes, prize winners or possible prize winners, must be present and made on-site in person to the race official, in a written format, within 15 minutes from the prize presentation, whichever is earlier. All appeals are subjected to a non-refundable appeal fee (RM100.00 ONLY).
6. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to replace any winners if he/she is found to be disqualified.
7. Participants who do not start within 30 minutes from their respective flag off point will be disqualified and for safety reasons, may not be allowed to start.
8. Participant must at all times follow the respective event route, the direction of security officials, traffic management officials, event officials and any enforcement officers.
9. Road closure where applicable will be lifted after completion of the race. The route will not be guarded by road marshals after the closure time. As per the instruction by the authorities, no participants are allowed to remain on the route after the closure time. If the participant proceed to run after the closure time it

will be at participant own risk. Timing will not be considered valid after closure time.

10. No pets or any form of wheel-run objects of transport e.g. inline skate, prams, shoes with built-in or attached rollers is allowed on the course during the race except officials race, baby strollers and medical vehicles.
11. *Dental Society, Faculty of Dentistry, University of Malaya* will not be held responsible for any loss and/ or damage, personal or otherwise, to participants' belongings.
12. Colour powder, bubbles and foam will be used during the run.

MEDICAL & SAFETY

1. Whilst every reasonable precaution will be taken by the organizer to ensure the participants safety, participants take part at their own risk and the organizer will not be responsible or held liable for any injury or death howsoever arising from training for or during participation in the race.
2. Organizer (*Dental Society, Faculty of Dentistry, University of Malaya*), sponsors and appointed officials shall not be liable for any death or injury, loss or damage, suffered or otherwise, and howsoever arising.
3. *Dental Society, Faculty of Dentistry, University of Malaya* reserves the right to remove any participant deemed physically unfit/ incapable to continue the run to prevent him/her from causing greater harm and injury to him/her.

4. Participant must retire from the event immediately if require to do so by any member of the event officials/ medical staff, race director, race secretariat or security officers.
5. Any casualty will be send to the nearest and/ or recommended hospital.
6. Participants accept and agree that the event carry certain inherent danger and risks which may or may not be readily foreseeable including without limitations to personal injury, damage to property or death and his/her participation in the event is voluntarily in spite of the potential risks and danger.
7. Participant warrants that he/she is in good physical condition and have sufficient preparations and is able to safely participate in the event. The participant is fully aware of the risks and hazard inherent in participating in the event, including the possibility of serious physical trauma, injury or death.
8. Participants are strongly encouraged to go for a medical examination and/ or consult their medical practitioner prior to registration and before the actual race day.
9. Participants are recommended to have your personal accident insurance or health insurance.
